3.	Rotational Post information	12 months post at Musgrove Park Hospital Internal rotation between consultants after six months.
4.	Training unit/location/s	Musgrove Park Hospital. Also some sessions at Yeovil General Hospital
5.	Full address of training units where training will take place	Main unit: Musgrove Park Hospital, Taunton, Somerset TA1 5DA Occasional teaching sessions: Yeovil General Hospital, Yeovil, Somerset, BA21 4AT
6.	Travelling commitment	Travelling to Yeovil Hospital once per week (this only applies to 1 or 2 DCTs at the time if no other commitments at Musgrove Park Hospital)
7.	Educational Supervisor	Mr Manuel Blanco-Guzmán
8.	Description of the training post	<p>These posts offer a significant exposure to oral surgery. The successful candidates will participate in oral surgery clinics and operating lists both under local and general anaesthetic. The trainees have also access to their own minor oral surgery lists with indirect supervision.</p> <p>The posts also involved exposure to some aspects of maxillofacial surgery involving facial deformity / orthognathic surgery, facial skin surgery, salivary gland pathology and surgery, temporo-mandibular joints and some aspects of head and neck intraoral cancer.</p> <p>The trainees are allocated one flexible study session per week. These sessions can be used to attend clinics for other specialties (Orthodontics and Restorative Dentistry) and also for completing Audits and Publications. Following the initial meeting with the Educational Supervisor, these sessions of their job plan can be designed to suit their individual developmental needs.</p>
9.	Primary Care training element	There is no Primary Care training element in this posts, however the timetables will allow the successful candidate to organise one or two sessions per month in a dental practice. This activity should not interfere with the post in oral and maxillofacial surgery and should be organised by the trainee with previous discussion with the educational supervisor.

10.	Pattern of working, including any on-call commitment	<p>On call: Not resident, 1:4 weekdays and 1:5 weekends Timetables varies slightly between DCTs, however all timetable will have access to training list in oral surgery (local and general anaesthetic), maxillofacial surgery and general clinics. Each DCT will also have her/his own (although supervised) dento-alveolar surgery list under local anaesthetic according to experience and development.</p> <p>All post are compliant with EWTD, New Deal and New junior doctors contract</p>
11.	Educational programme summary and library facilities	<p>There is a postgraduate library at Taunton which holds a good number of relevant journals. Basic textbooks are also available and some further textbooks are available within the Department. Regular meetings are held in the Postgraduate Centre on Wednesdays/Fridays on all topics of medical interest and junior staff are encouraged to attend.</p> <p>The department has an Educational Supervisor who is responsible for the overseeing the appraisal and education of the DCTs. There is a programme of educational meetings/sessions which occur on a regular basis.</p>
